**COUNT 1: ASSAULT AND BATTERY, 21 O.S. § 644(B), a MISDEMEANOR**

**COUNT 2: DOMESTIC ASSAULT AND BATTERY, 21 O.S. § 644(C), a MISDEMEANOR**

*IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:*

By the order of the Supreme Court of Oklahoma, the Twenty-First Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from December 16, 2024, for eighteen (18) months, or until the designated presiding judge determines the Twenty-First Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

**COUNT 1: ASSAULT AND BATTERY, 21 O.S. § 644(B), a MISDEMEANOR**

On or about July 26, 2025, in Coal County, Oklahoma, **JASON SMITH** committed the crime of **ASSAULT AND BATTERY**, a Misdemeanor, by willfully and unlawfully using force or violence upon the person of another, to wit: by hitting [REDACTED] with the unlawful intent to do him corporal hurt and bodily injury, contrary to the provisions of Title 21 O.S. §644(B) and against the peace and dignity of the State of Oklahoma.

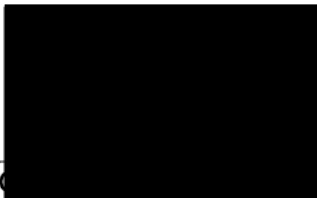
