NARRATIVE No: 1 - Officer: WARREN, STEVE

On October 20, 2022, I Deputy Steven Warren currently employed with the Pottawatomie County Sheriff's Office was informed by Central Dispatch of a phone message in GeoSafe with the location around Bethel Schools.

Upon call back of the number provided I made contact with SHEENA MARTIN, who states that for 2004 to 2016 she was sexually abused in some way by the at that time band director of Bethel School who she named as DAVID IRBY.

SHEENA continued to tell me over the phone that starting in 2004 she was 14 at that time DAVID began to groom her through different online platforms. SHEENA states that this went on for approximately 2 years and in 2006 at the age of 16 it became more physical in nature.

SHEENA states that DAVID picked her out due to the abusive and "broken" home that she was a part of, that DAVID made her feel important and stated several times that he would leave his wife for her. SHEENA continues with once it became physical that things would happen "anywhere and everywhere" including his office at the school, lunch breaks and evening adventures.

SHEENA says that the events never stopped until 2016, which is also her last contact with DAVID which she said she sent him a message with the context of "you know it was wrong and why did you do this to me". SHEENA was asked several times if he ever replied to the message, but she avoided the answer.

SHEENA felt most compelled to come forward after she had heard there may be other victims. As of DAVID his last known teaching job was Irving Middle School in Norman Oklahoma, but this has not been verified.

I Lieutenant Dakota Black being the undersigned person, being duly sworn upon her oath, hereby depose and state as follows:

On October 1st, 2024, I spoke with Brad DeLozier, an investigator from the Oklahoma State Board of Education. He informed me that an additional victim had come forward in the case involving David Irby [REDACTED] and that he had gathered new information. I requested the details from Brad, but he advised me that he had already forwarded his investigation to ADA McConnell for review.

Later that day, I contacted ADA McConnell to confirm whether she had received the file from Brad. McConnell confirmed receipt and stated she would be reviewing the file soon. I informed her that if any new victims or information surfaced that could support Sheena Martin's [REDACTED] claims against David Irby, I would like to be notified so the investigation could be reopened. McConnell assured me she would inform me once she completed her review.
